

# ARE RECIPIENTS (the state, cities, businesses, individuals) PREPARED TO:

- 1) Sign the <u>US DEPT OF TREASURY AWARD TERMS AND CONDITIONS</u> that requires all Recipients to comply with all applicable federal statutes, regulations and executive orders.
- 2) Receive an executive order to force their employees and subcontractors to receive the COVID-19 vaccines to keep their jobs, even though that would be in direct conflict with Governor Abbott's Executive Orders prohibiting vaccine mandates?

ACTION: Interim Final Rule

From page 3 of the Interim Final Rule which states:

"Amid this once-in-a-century crisis, State, territorial, Tribal, and local governments (State, local, and Tribal governments) have been called on to respond at an immense scale. Governments have faced myriad needs to prevent and address the spread of COVID-19, including testing, contact tracing, isolation and quarantine, public communications, issuance and enforcement of health orders, expansions to health system capacity like alternative care facilities, and in recent months, a massive nationwide mobilization around vaccinations."

#### 9. Compliance with Applicable Law and Regulations.

a. Recipient agrees to comply with the requirements of section 603 of the Act, regulations adopted by Treasury pursuant to section 603(f) of the Act, and guidance issued by Treasury regarding the foregoing. Recipient also agrees to comply with all other applicable federal statutes, regulations, and executive orders, and Recipient shall provide for such compliance by other parties in any agreements it enters into with other parties relating to this award.
